



A continued dynamic of solid growth

The first 9 months 2011 activity confirmed once again Group Crit ability to grow with sales up 16.2% and 15.2% at constant scope.

In Q3 2011, the Group realized a solid growth with sales up 11.8%. This evolution includes the activity of the North American staffing company PeopleLink, acquired and consolidated in the group as from September 2011. At constant scope, the commercial dynamic remained sustained with Q3 sales of € 419.8 million, up 9.2% over the third quarter of 2010.

Temp. business: + 17.9%

For the first 9 months, Temp. Business (84.3% of total sales) amounted to € 945.1 million⁽²⁾, an increase of 17.9% (+16.8% at constant scope).

In Q3 2011, Temp. business sales rose by 12.5%, to € 339.4 million⁽²⁾. At constant scope, sales increased by 9.4%. France confirmed its good dynamics with sales amounted to € 305.4 million⁽²⁾, up 9.7%.

Multiservices : + 7.7%

For the first 9 months 2011, Multiservices business sales amounted to € 188.5 million⁽²⁾, increasing by 7.7%. As expected, the group consolidated its growth in Q3 with sales of € 66.4 million⁽²⁾, up 8.1%. In Airport activities (73.5% of multiservices) sales amounted to € 48.8 million⁽²⁾ vs. € 47.1 million⁽²⁾ in Q3 2010. The Engineering and Maintenance activities achieved a strong growth in Q3 with sales of € 13.7 million⁽²⁾, up 24%.

Given these favourable evolutions, Group Crit confirms its confidence in its capacity to achieve a year of growth in activity and to improve its profitability.
