



Strong performance in H1

Revenue up 11.5%

French staffing growth up + 15.1%

Above €1 billion in H1 2016

Groupe CRIT delivered an excellent H1 exceeding, for the first time, revenue of €1 billion over the period. With 11.5% growth, H1 2016 revenue amounted to € 1.024 billion vs € 918.6 million in H1 2015. Both France and international contributed to this growth. In France, (78% of H1 total revenue), the group confirmed its dynamic with revenue growing organically by 13.7% to € 790.7 million. Q2 revenue, up 9.6%, remained particularly dynamic despite a high comparison basis with Q2 2015 up 17.5%.

Staffing & Recruitment division: up 12.6%

H1 staffing & recruitment division (85.3% of total revenue) amounted to € 874.2 million ⁽¹⁾ posting a strong increase of 12.6% despite a high comparison basis with H1 2015 up 17.4%.

France : organic growth up 15.1%

French staffing activities recorded an excellent organic growth up above 15% to € 661.6 million, twice the market growth (up 7.5% on the 5 months ended May - source Prism'emploi). This sustained growth confirmed, once again, the strong momentum of the group in the industrial sector, particularly in the automotive. Following Q1 2016 growth of 17%, the group staffing division continues its sustained growth in Q2 with revenue up 13.4% compared to Q2 2015. Thus, the Group continues to outperform its market and confirms its capacity to take full advantage of the improved economic environment.

International growth up 5.4%

Staffing international operations grew by 5.4% in H1 to € 212.7 million. Spanish operations continue their growth momentum with H1 revenue up 17.5% to € 50.4 million. US operations posted an increase of 2.3% in H1, impacted by a decline in April and May activities (revenue down 3.9% in Q2 2016 mainly due to IT and quality control activities).

Multi-services division up +5.4%

In H1 2016, Multi-services division posted revenue up 5.4%, to €158.7 million ⁽¹⁾. In Airport services (72.8% of activity of the division), half-year revenue grew by 3.5% to €115.6 million, driven by the activity in France posting H1 revenue of € 94.6 million up 4.7%.

In View of this successful first half-year, the group remains confident for the second half of the year and confirms its objective to exceed 2 billion euros in revenue in 2016
