2007 sales: +11.4% The Temp. Business segment outperformed the French market

Group Crit sales amounted to M€ 1 450.7 in 2007, posting an increase of 11.4%.

Q4 sales confirmed the sustained activity of the Group with an increase of 7.7% at million euros 369.2 M€.

Temp. Business: +13%

In Temp. Business segment (88.2% of sales), 2007 annual sales reached 1 280.1 million euros, posting an increased of 13%. In Q4 2007, growth increased by 7.4% with sales of 324,5 million euros.

In France, full year sales grew by 11.2% at 1 182.6 million euros. Over the same period, the growth in Temp. market in France is estimated at 6.5%. Q4 activity confirmed this outperformance with an increase of 8.4% to 300.1 M \in .

Outside France, the group reached an important step in 2007 with an increase of 38.8% to 97.5 million euros. This dynamics which profits from integration in full year of the 2006 acquisitions in Spain, allows the Group to realise more than 7.6% of its temp. business activity abroad.

Engineering & maintenance : a continuous improvement over the months

In Q4 2007, the engineering and maintenance activities posted sales to 15.3 million euros, showing an increase of 25%. This strong growth confirms the continuous improvement of activities over the months. In full year 2007, sales confirmed their stability at 54.2 million euros.

Airport: ready for a two digits growth in 2008

In Airport business, Q4 2007 sales amounted to 26.4 millions euros, posting an increase of 3.5%. This evolution takes partially into account the new contracts signed over the last months that will stimulate the growth in 2008. Among last recorded commercial successes, we note the 3 important contracts signed with British Airways and Easyjet which represent an amount of 85 million euros over 3-4 years.

In full year 2007, Airport sales to 105.8 million euros were in line with expectations.

Based on this successfull end of year, the Group begins 2008 confidently.
